

## Terms & conditions Euromarkt 2012

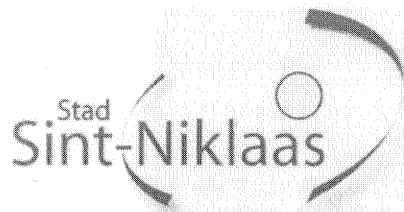
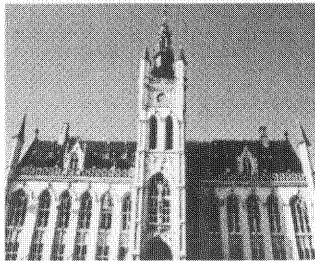
3- 4- 5 August 2012, Sint-Niklaas, Belgium

1. All merchants, trades people and market peddlers, Belgian as well as foreign, are permitted on the Euromarkt 2012 as long as they offer regional typical products or specialties.
2. The Euro market takes place on the following days at the Grote Markt in Sint-Niklaas (Belgium):
  - Friday 3<sup>rd</sup> of August 2012 (from 2 pm till 11 pm);
  - Saturday 4<sup>th</sup> of August 2012 (from 10 am till 11 pm);
  - Sunday 5<sup>th</sup> of August 2012 (from 10 am till 6 pm).

The market stalls can be placed starting from Friday 3<sup>rd</sup> of August 2012 at 10 am exactly. All places must be taken one hour before the opening of the market. No stall holder can leave the market square before the end of the market.

3. The participation is free for all traders, who meet all criteria as mentioned in article 1.  
Only for Belgian participants: A deposit of 250 EUR is fixed for all Belgian participants for the three market days, to be paid into the account of the city. After the end of the Euromarkt the deposit will be refunded for all the Belgian participants who were present.
4. The ultimate date for registration to the Euromarkt is 1<sup>st</sup> of June 2012. Participants have to use and sign the official register form. This should be sent back either per mail (Town of Sint-Niklaas, Euromarkt 2012, Grote Markt 1, B-9100 Sint-Niklaas), or by fax (+32 3 766 08 82) or e-mail (scanned document): [info@sint-niklaas.be](mailto:info@sint-niklaas.be). It is not possible to register by phone.
5. In assigning the places the organizers will spread the offered regional products, according to the chronology of the registration. The depth of the market stalls is maximum 4 m. If the participant wants to exceed this depth, he needs a special authorization from the city council.
6. The Town Council can refuse participants if necessary and with justification.
7. The registration is definitive as soon as the registration form is signed and the registration is confirmed by the Town Council. For Belgian participants also the deposit need to be paid. In case a participant fails to come, the deposit will not be paid back, even if another participant takes the assigned place. Subleasing places is strictly forbidden.
8. Every participant is obliged to apply the actual Belgian legislation, especially concerning food hygiene.

9. The market leader will design a plan for the Euromarkt. The participants may not switch places or take in someone else's place without consent of the market organizer.
10. Market stalls must be organized and decorated properly. The dimensions mentioned in the registration form and on the plan must be respected. No exceptions will be allowed. If necessary, participants can ask for a market stall that is from the town administration.
11. The electricity is delivered in 220 V. The organizers cannot be held responsible for unexpected electricity cut-offs.
12. Sound installations may not bother other participants.
13. It is forbidden to leave any garbage or packaging materials on the market square. Free garbage bags will be distributed. At the closing of the Euromarkt, the participants can deposit all garbage and packing materials in special garbage trucks.
14. Market peddlers and participants who do not respect these regulations can be removed from the market square without any compensation.
